Warranty Information:

Brokered Parts unless otherwise stated on your receipt, come with a standard warranty.

New Aftermarket Parts unless otherwise stated on your receipt, come with a standard warranty.

Exchange/Return/Refund Policy if the part purchased from Nevill's Auto Salvage, Inc. is damaged, broken, or of non-working order then a replacement part can be exchanged with the same Nevill's Auto Salvage, Inc. part or part brokered from another yard before a refund will be issued. Refund will be issued as store credit only. If the incorrect part has been ordered due to incorrect information given by the customer, the part is not needed, or the part did not fix your vehicle's issue there is a no exchange, return, refund policy.

Standard 30-Day Warranty - Parts Only

Includes the part purchased from Nevill's Auto Salvage, Inc. only, this does not include labor, fluids, belts, hoses, gaskets, grease or any other part or accessory purchased from any other company or vender. Warranty is for replacement of the same part ordered, with-in 30 days of your original receipt date. Original receipt must be presented at time of warranty, exchange, return, or refund request.

Deposits have no exchange, return, refund policy.

Parts left over 14 days have no exchange, return, refund policy. These parts will be sold again.

Engines are described as block and cylinder head assembled as a unit with valve covers and oil pan. Fuel systems, distributors, idle valves, wiring and exhaust manifolds are not covered under this warranty.

To validate warranty, the following steps MUST be taken at time of installation:

Install oil and filter, replace plugs, wires. Leaks are not warranted, maintain proper oil and coolant levels at all times. Heat tabs have been installed by Nevill's Auto Salvage, Inc. – removal, tampering, or melting of these tabs VOIDS warranty.

Cylinder Heads are guaranteed to have no cracks, guaranteed machine able to with-in manufactures specs, valves, spring, studs, pins, gears, nuts bolts, etc. are not guaranteed. We recommend all heads be checked by a machine shop for cracks or warpage.

Transmissions are described as a unit not to include shift cables, linkage or levers, modulator valve or electrical switches. Automatic units include torque converter. Converter must be indexed completely into the front pump before installation.

To validate the warranty, the following steps MUST be taken at time of installation:

Install new fluid and filter, change all seals and gaskets. Leaks are not covered under warranty. All over-drive lock-up and front wheel drive automatics must have adjustments set by a certified technician.

Air Conditioning Parts to validate warranty, the following steps must be taken at time of installation:

Flush to clean the system, vacuum to remove moisture. Never liquid charge system. Change dryer or accumulator and orifice tube.

Electrical Parts have no warranty and are sold as is. Each part is checked and in good working condition prior to leaving Nevill's Auto Salvage, Inc. If your problem persists after installing our part, there is a no exchange, return, or refund policy.

Upon signing the front of the Nevill's Auto Salvage, Inc. receipt you release and relinquish all rights to bring a legal suit against Nevill's Auto Salvage, Inc., its employees, associates, or owners for any reason. If you bring a legal suit up against Nevill's Auto Salvage, Inc., its employees, associates, or owners you agree to pay all legal and attorney fees associated with the suit for Nevill's Auto Salvage, Inc., its employees, associates, or owners.
